Through this testimony I certify the fact of the introduction and dissemination by me of the Teaching of Grigori Grabovoi, with good results, which consists of the following:

1. My first contact with the Teaching of Grigori Grabovoi was in **2017**.
2. In the process of learning the Teaching, I became convinced that it has a creative nature and is accessible so that everyone can learn it.
3. In the implementation of Grigori Grabovoi's Teaching I used the control methods exposed in the works of Grigori Petrovich Grabovoi.

On March 16, from 8:30 pm, when I was at work, I suddenly felt changes in my body, and I felt strange tiredness, soon I began to feel very dry dry throat, dryness went down to the trachea and there was a feeling of irritation or stagnation in the upper parts of the lungs (similar to what I felt with an allergic reaction to cats). This feeling of extreme dryness was not relieved. After some time, I began to have severe inflammation in the back of my neck, which caused a headache from the base of the skull. I also began to feel swelling in the upper back and swelling of the joints. At the end of the working day, I returned home and went to bed with the

same feelings. I just wanted to rest and not think about anything, nor did I want to ask myself if it was a coronavirus, or rather, I thought I just got cold due to a very sudden change of the temperature that happened that day, and that's why I felt bad ... very strange and I was upset. I constantly woke up from discomfort and felt that my body temperature rose from time to time, but I did not have a thermometer to check if I had a temperature.

In this state and somewhat worried about the possibility of getting COVID-19, I finally decided to connect to the PRK-1U device through my mobile phone. Since I was still lying in my bed from discomfort and because it was still night, I took the phone in my hand and just started looking at the device, switching my thoughts from a small lens to other lenses counterclockwise.

I made a very conscious and intense observation of the device because the symptoms intensified, and from time to time I felt as if I were holding on to the life buoy that holds me, helping to avoid getting more and more involved in this symptomatic disease process

Little by little I felt relieved, and as a kind of information field that kept me in such a physical "struggle", it fell from my body to my knees ... And only now I realized that I had to work concentrating on my knee joints for protection. The fact is that this awareness was very clear, all these feelings were concentrated in my knees, and pretty quickly I began to relax until I fell asleep and fell asleep soundly. The sense of relief and change was truly obvious and effective.

A few hours later, I woke up later than planned, stunned, because I had to notify my work about what happened to me, so that they could evaluate whether I should go to work or not, because I was already in very good condition and without symptoms. They indicated that a general case should be applied for cases considered to be "symptoms compatible with COVID-19".

Thus, I remained on sick leave and isolated, although I did not have cough, fever or suffocation (as described for the specific symptoms of this infection). That is, I did not imagine serious complications. In fact, at all the moments in which some symptoms appeared and were already less pronounced, and I worked with the PRK-1U device, the symptoms decreased until they finally disappeared.
