



**The result of Grigori Grabovoi.
Testimony of Mushkudiani Teymuraz.
Restoring the health of the son
of Mushkudiani - George.
Diagnosis: IV stage bone-marrow
rhabdomyosarcoma
with bone marrow lesion.**

I, Mushkudiani Teymuraz Georgievich, testify, that Grigori Petrovich Grabovoi had restored my son

Mushkudiani Georgiy's health from IV stage bone-marrow rhabdomyosarcoma with bone marrow lesion, with pelvic bone metastasis, femoral bone on the left, with a non-contact method.

Proof of this is that on May 3, 1995, my son, Mushkudiani Georgy Teymurazovich (born 1985), was hospitalized in the Research Oncology and Medical Radiology of the Ministry of Health of the Republic of Belarus, located at the address: Minsk Region, pos. Borovlyany (0172) 65-42-21.

There, on the basis of morphological research No. 9413/95 dated 3rd May 1995, Dmitry Vitalievich Kochubinsky, the Head of the Children's Department had made a diagnose: "Fetal rhabdomyosarcoma of the upper jaw on the right".

The analysis of computed tomography, conducted on 6th May 1995, identified: a massive soft tissue tumor of the oropharynx rotor with a size of 8.5x7.5x6.5mm, mostly on the right with germination in the right maxillary sinus, pterygopal fossa, main sinus, right half of the nasal cavity, with destruction of the right zygomatic bone, with metastases in the submandibular lymph nodes to the right up to 2.5x3.0 cm in diameter.

Cytological conclusion № 9668/95, dated 6 May 1995, showed a plaser of cells of an immature malignant tumor of non-epithelial origin, corresponding to rhabdomyosarcoma in its characteristics.

Histological examination No: 24537-42 dated 5th May 1995, showed that in all the delivered areas there is a malignant tumor, alveolar rhabdomyosarcoma.

The myelogram, conducted on 5th May 1995, showed, in the background of the elements of the bone marrow, separately lying and in combination atypical cells.

The child was prescribed chemotherapy and radiation treatment according to the CW1-91 protocol.

Three courses of chemotherapy and radiation (10 grays) given to the child did not give real results - the tumor from the upper part of the face moved to the neck. The child had a headache, insomnia, constant malaise.

Having read in the newspaper "Business World" (dated June 17, 1995) , the article by V. Sudakov - "The X-ray Man" , about an extrasensory man Grigori Petrovich Grabovoi, I had contacted the editor of this newspaper, Y. Kirpichnikov, with a request to introduce me to G. P. Grabovoi.

On 3rd July 1995, V. Sudakov had passed my plea regarding a help for the recovery of my son to G.P. Grabovoi.

Two weeks later - on July 17, my son's tumors began to noticeably decrease and after 3 days on July 20, 1995, they had completely disappeared.

The whole period of G.P. Grabovoi's healing sessions, the work was carried out without any medical and surgical intervention.

I discharged my son from the clinic, took him home to Tbilisi and to this day he does not take any medications and is at home.

On September 1, 1995, he went to school and is studying to be an excellent student.

After our return from Moscow, on July 24, 1995 and July 26, 1995, at my strong request, at the same clinic where my son was treated, there had been carried out the following control tests: morphological studies No. 19997/95 and No. 40392-93, which showed that no tumor cells were found in the bone marrow, lymph nodes, nor in the jaw.

The above is confirmed by the discharge statement and a certificate issued on August 10, 1995 by the Head of the Children's Department of the Clinic, Dr. Dmitry Vitalevich Kochubinsky.

I now have this certificate in my hands with the signature of the Dr. Dmitry Vitalevich Kochubinsky with the seal of the clinic, where it is stated that , parents of Mushkudian Georgiy took the patient to the extrasensory consultant G.P. Grabovoi. And that after their return from Moscow, there had been made the repeated analyzes on Mushkudian Georgiy.

Cytological examination dated July 25 and 29, 1995 did not show tumor cells, and bone marrow analysis did not show the presence of tumor cells either.

Now in front of me , I have the original documents. Here is a histological study, histological studies. Computer images, X-ray results, which showed and confirmed the above diagnosis, that the child had IV stage rhabdomyosarcoma.

Also cytological analysis carried out after our return and a course conducted by G. P. Grabovoi, where it is specifically indicated that everything is absolutely clean, cytological analysis denying the presence of cancer, no histological analysis had been performed, because the child had healthy tissues, and doctors refused to take healthy tissues to make histological analysis.

This is also confirmed by my wife Mushkudian N.A, who was here the whole period from 3rd May till 10th August 1995.

And it seems to me that the best proof of everything that had happened, and how Grigori Petrovich Grabovoi rescued our son from death, and our son is now alive and healthy, he is a schoolboy, excellent student and absolutely healthy person in all respects.
