I stayed on the floor for a few minutes. My husband, Damián, was very scared and he spoke to me and I only thought of Dr. Grabovoi. with difficulty I got up and sat in front of the PRK-1u

To all this it seemed that I had both kneecaps swollen, I could not take a step, my right hand could not close, the joint of the little finger swollen, my face hurt and I had a large scratch on my right cheekbone. I worked with the PRK of "rejuvenation), about 10 minutes. But I was urgent to work with the control of the scan with both hands (5 min.) I started to get into a lot of harmony, then I started with my right index finger, which was quite painful There I started to feel strong pain in the knees, my face hurt a lot but and my little finger looked much "thinner." I was still in concentration and I started to see a golden thread on the inside of the little finger and the pain thickened to "leave".


When I finished the control. I was calm, my face was not swollen, my hand could close and flex my fingers and I could walk. The most important thing I WAS NOT SCARED (my husband, Damian either), I slept well, I woke up much better , now I can handle my hands, of course there is some discomfort but it is very little. .
