Appealed to Grabovoi G.P (Passport series III-OG № 586058, issued 01.02.1980, certificates series A № 018465 & series A № 018466 for extrasensory activities) to diagnose the body of his grandson - Manuylov Dmitry Alekseevich (born 03.09 .1985) and to treat via non-contact extrasensory method, episynndrome, established in his grandson in 1988.

As a result of extrasensory diagnostics performed by Grabovoi G.P, there was a coincidence with the diagnoses of medical institutions. 17 July 1994, Grabovoi G.P had begun extrasensory remote treatment of "episynndrome" of the grandson. Medical diagnosis of episynndrome, established on the same device for the last 5 years at the MMA. named after Sechenov, Rossolimo Street 11, confirmed presence of episynndrome.

In fact, instrumental diagnostics on 02.06.1994 (before contacting Grabovoi G.P) showed pronounced negative dynamics in comparison with the records from 1993. After a course of remote treatments, performed by Grabovoi G.P from 17.08.1994, instrumental diagnostics on 19.09.1994 showed decrease in epileptic, and instrumental diagnostics on 22.12.1994 showed clear positive dynamics.

22.12.1994 Electroencephalography

In the background, moderate diffuse changes of epileptic EA with irregular α -rhythm 10
/ s 50-75 mm in the occipital regions, diffuse slow activity 0 to 50 mm with bilateral
synchronous propagation, generalized α -activity (in the anterior parts up to 15 mm). For
rhythmic photostimulation - bilaterally synchronous 0 to 50 mm.

Hyperventilation strengthening of slow activity, in occipital and parietal departments 5 / s
to 150 mm-175 mm without generalization.

CONCLUSION: Mild cerebral changes in epileptic EA with a decrease in the threshold
of convulsive readiness.

In comparison with the record from 19.IX.1994, clear positive dynamics.
