I declare that Grigori Petrovich Grabovoi really cured me from cystoma.

My cystoma was discovered during an ultrasound scan in 1995 at hospital No. 54 in Moscow. Same diagnosis was confirmed again by ultrasound scan in the antenatal clinic No. 15 of Moscow in 1996.

After the treatment by with Grigori Petrovich Grabovoi held on 02.10.1997, I had another ultrasound scan on 23.10.1997 in the antenatal clinic No. 15 of Moscow and cystoma was not found.

Please assure my statement on the basis of my ID documents provided and on the basis of the above evidence.

**Discharge Epicrisis**

Patient Halipova L.P. 56 years, profession: teacher, hospitalized in the gynecological department. 34

from 12/18/1996 to 12/30/1996.

Diagnosis at discharge: cystoma of the left ovary, uterine fibroids 6 weeks.

Complaints: blood spottings in postmenopausal period.

Condition at admission: satisfactory.

Condition at discharge: satisfactory.

12/18. diagnostic and curettage of the uterine mucosa was performed.

Clinical examinations: December 18, 1996

Hemoglobin: 122. White blood cells: 7.1. P: 1. C: 66. L: 30. M: 3. ESR: 5.

General urine test: 12/19/1996

Reaction: acidic. Beats weight: 1012. Protein: no. Sugar: no. White blood cells: 4-6.

FGS 12/23/1 996, ulcer of the duodenal bulb.

RRS - proctitis.

Ultrasound test December 27, 1997 - liver is slightly enlarged (lower edge 4-5 cm below costal arch), smooth contours, inhomogeneous echostructure, without focal changes. Gall bladder is not enlarged, with smooth walls. Bile ducts are not dilated, pancreas and spleen b / o. Right kidney is not visualized (nephroectomy), left kidney is not enlarged, with smooth contours. Body of the uterus is enlarged to 6 weeks, due to small nodules - heterogeneous. On the left, above left kidney thick-walled, single-chamber, liquid formation up to 90 mm without wall inclusions.

Irrigoscopy 12/24/1996 - the phenomenon of colitis.

Location of the chest - without features.

Electrocardiography 12/20/1996, deviation of the electrical axis of the heart to the left.

Therapist consultation.

In satisfactory condition, is discharged from the gynecology department. Surgical treatment is recommended as planned.

Given the previous nephroectomy, urologists consulted - surgical treatment was recommended in the conditions of KGB No. 50, City Clinical Hospital No. 1, Extracorporeal analysis.

Ultrasound from 12/18/1996

Uterus is 6.7x5.8x5.6 cm. On the front wall in the area of the isthmus, subserous node d = 2.7 cm. M - echo linear - reflection bright, thickness 0.4 cm.

Right ovary is 2.1x1.7x2.0. Structure is ordinary.

Left ovary - on the left and on the top, formation is 8.9x6.4 with finely divided contents, single chamber, with smooth walls.

Conclusion: cystoma of the left ovary, smooth-walled, uterine fibroids of small sizes.

Endometrial hyperplasia.

Ultrasound:10/23/1997

Uterus: 6.5x4.0x5.9. Contours are fuzzy, uneven. On the front wall, subserous nodule with a size of d = 2.0 cm.

M-echo - TMN, homogeneous.

Reflection from endodometry is average.

Right ovary: 2.8 × 1.6 × 2.5 of normal structure.

Left ovary: 3.0 × 1.5 × 2.3 normal structure.

Conclusion: uterine fibroids are small.
