On March 24 - 1994, at the Republican Oncology Center of the Ministry of Health of Bashkiria, located at: Ufa, Oktyabrya Avenue, 73/1, tel. 24-25-29, I, Antipova Galina Stepanovna, had a cytological test of smears isolated from the right nipple of the mammary gland under No. 4988 of March 24, 1994. As a result of cytological test No. 4988 of March 24, 1994 I had the following form of cancer: intraductal carcinoma. At the time of diagnosis, I had bloody discharge from the nipple of the right breast. After the diagnosis was established: intraductal carcinoma, I decided to undergo a course of non-contact extrasensory treatment carried out by Grabovoi Grigori Petrovich at any distance from him. For the period from March 30, 1994 to April 3, 1994, as a result of the extrasensory work of Grabovoi Grigori Petrovich, blood discharge from the right chest was stopped. Treatment was carried out daily from 22:00 to 23:00 PM local time. During the session, the location did not matter, there were no restrictions (another city, village, place of work, place of rest). nipple of the right breast was carried out No. 143647 of August 29, 1994. The second examination was conducted by the same doctor, head of the department of breast tumors, Vakhit Lutfrahmanovich, honored doctor of Bashkiria Mukhamedyarov, working tel. 24-27-74. The second cytological examination of the punctate of the right breast revealed that I did not have cancer. The foregoing was recorded in the conclusion of the Republican Oncology Dispensary of the Republic of Bashkiria, Ufa, Oktyabrya Avenue, 73/1. Until the diagnosis of cancer on March 24, 1994, I did not take any medication. In the period from March 24 to August 29, 1994, only non-contact treatment was carried out by Grabovoi Grigori Petrovich. I am sure that Grabovoi Grigori Petrovich cured me of cancer, which is confirmed by medical tests. For the period from August 29, 1994 to June 26, 1996, objectively, I was practically healthy, no discharge from the breast was repeated, my health was normal, I did not have objective complaints. For this period, I had been permanently working as the chief accountant of the bank. I did not have to appeal to medical institutions for health reasons because I did not need it.
