STATEMENT

on the establishment of the fact of recognition of Grabovoi Grigori Petrovich healer and clairvoyant

Name of the document, series, number, by whom and when the document was issued: I have an identity card: passport XIV-TH No. 554003.

Due to the fact that I applied to Grabovoi Grigori Petrovich who was born on November 14, 1963 in the village of Kirovsky, Kirovsky district, Chimkent region of the Kazakh SSR (who has the birth certificate of series II - OG No. 463794, passport of the III-OG series No. 586058, issued on 01.02.1980) through the newspaper "DELOVOY MIR" due to the illness of my son.

I declare that Grabovoi Grigori Petrovich really cured my son Georgiy Mushkudiani, 10 years old.

In May 1995, doctors of the Tbilisi Oncology Hospital and doctors of the Belarusian Research Institute of Medical Radiology and Oncology diagnosed my son with rhabdomyosarcoma of the oral-nasopharynx with a zygomatic bone lesion on the right and a bone marrow lesion. The child was almost blind in his right eye, could not walk, complained of impossible pain throughout his body.

At the Belarusian Scientific Research Institute of Medical Radiology and Oncology, my son was given 3 courses of chemotherapy, and they started to do radiation, when, seeing that no results were expected, I applied to Grigori Petrovich Grabovoi through the newspaper "Delovoy Mir". The correspondent of the newspaper V. Sudakov contacted Grabovoi G.P. on 06/03/1995 and Grabovoi G.P. started contactless treatment. After 2 weeks, on July 17, the tumors began to noticeably decrease and after three days completely disappeared. Numerous tests carried out in the same clinic (attached) showed that the child was completely healthy, no cancer cells were found anywhere.

Please certify my statement on the basis of documents proving my identity and on the basis of the above testimony.

I, Mushkudiani Teymuraz Georgievich, state: citizen of the Republic of Georgia,

name of the document, series, number, by whom and when the document was issued: I have an identity card: passport XIV-TH No. 554003,

I certify that Grigori Petrovich Grabovoi, using a non-contact method, healed my son Georgiy Mushkudiani from rhabdomyosarcoma of the nasopharynx with bone marrow damage, stage IV, with pelvic metastasis and the femur on the left. The evidence is given below: on May 3, 1995, my son, Mushkudiani Georgiy Teymurazovich, who was born in 1985, was hospitalized at the Scientific Research Oncology and Medical Radiology of the Ministry of Health of the Republic of Belarus, located at: Minsk region, settlement. Borovlyany (0172) 65-42-21, where on the basis of morphological research No. 9413/95 of 05/03/1995 the head of the children's department of the same clinic D.V. Kochubinsky established the diagnosis: "Embryonic rhabdomyosarcoma of the upper jaw on the right". The analysis of computed tomography performed on 05/06/95 determined a massive soft tissue tumor of the nasopharynx 8.5x7.5x6.5 mainly on the right with germination in the right maxillary sinus, pterygopalatine fossa, main sinus, right half of the nasal cavity, with the destruction of the right zygomatic bone, with metastases in the submandibular lymph nodes on the right up to 2.5x3.0 cm in diameter. The cytological conclusion No. 9668/95 of 05/06/95 showed placers of cells of an immature malignant tumor of nonepithelial origin, corresponding in its characteristics to rhabdomyosarcoma. Histological examination 24537-42 of 05/05/1995 showed - in all delivered areas - a malignant tumor, alveolar rhabdomyosarcoma. The myelogram on 05/05/1995 (reflected in the discharge epicrisis and medical history) showed atypical cells against the background of bone marrow elements separately lying and in the complexes. The child was prescribed chemotherapy and radiation treatment according to the protocol CW1-91. Three courses of chemotherapy

and irradiation (10 gray), conducted for the child did not give real results - the tumor from the upper part of the face moved to the neck.

After reading in the newspaper "Delovoy Mir", dated 06/17/1995, the material of V. Sudakov "X-ray Man" about the psychic Grigori Petrovich Grabovoi, I contacted by telephone the editor of this newspaper Yu. Kirpichnikov with a request to connect me with G.P. Grabovoi, V. Sudakov transmitted my request for the treatment of my son to G.P. Grabovoi on 07/03/1995, after two weeks, on July 17, the tumors in my son began to significantly decrease and after 3 days completely disappeared.

The entire period of treatment by G.P. Grabovoi of my son was carried out without any medical or surgical intervention. After my son was discharged from the clinic, I took him home in Tbilisi and to this day he does not take any medicine and is at home. On September 1, 1995, he went to school and is doing very well.

At my request, in the same clinic where my son was treated, on July 24, 1995 and July 26, 1995, he underwent control tests - morphological examination No. 19997/95 and No. 40392-93, which showed that no tumor cells were found either in the bone marrow or in the lymph nodes, or in the jaw.

The aforementioned is confirmed by a written out epicrisis and a certificate issued on 10.08.1995 by the head of the children's department of the clinic D.V. Kochubinsky.

EPICRISIS MUSHKUDIANI GEORGIY TIMUROVICH, born in 1985

Diagnosis: rhabdomyosarcoma of the oropharynx, with damage to the zygomatic bone on the right. Metastases in the submandibular lymphatic nodes on the right, bone marrow damage, stage 4.

He was admitted with severe symptoms of intoxication, with complaints of severe pain in the bones of the lower extremities.

CT of 06.05.95 determines a massive soft tissue tumor of the nasopharynx $8.5 \times 7.5 \times 6.5$ is detected mainly on the right with germination in the right maxillary sinus, pterygopalatine fossa, main sinus, right half of the nasal cavity, with the destruction of the right zygomatic bone, with metastases in the submandibular lymphatic nodes on the right up to 2.5×3.0 cm in D.

05/06/95 R-graphy of the pelvic bones, hips: no bone-destructive changes were detected. Pictures have been interpreted by the head. Dep. Golub G.D.

05/06/95 R-graph organs of the chest: without pathology.

05/05/95 consultation of neurologist: complaints of decreased vision (OD-abs), pain in the legs and pelvis and when walking (currently does not walk), right-sided exophthalmos, muscle strength in the legs reduced to 2-3b, tendon reflexes D = S; no loss of sensitivity. Soreness in the left thigh and pelvic bones when performing tests of Lasseg, Matskevich, Basserman. Conclusion: metastases in the pelvic bone, left femur.

05/05/95 open biopsy of / maxillary I / y on the right, maxillary sinus biopsy, bone marrow puncture.

Cytological conclusion No. 9668/95: placers of cells of an immature malignant tumor of non-epithelial origin, which in their cytomorphological characteristics correspond to rhabdomyosarcoma. Elements of the bone marrow, destroyed, dystrophically altered cells of a malignant tumor.

Histologist. 24537-42: in all delivered areas, the malignant tumor is alveolar rhabdomyosarcoma.

Myelogram of 05/05/95: against the background of bone marrow elements, atypical cells lying separately and in complexes.

05/06/95 examination of the cerebrospinal fluid: no cellular elements were found, protein 0.224g / I.

Neurospecific enolase 235 ng / ml.

05/06/95 of otolaryngologist: malignant tumor of the upper jaw on the right with spreading into the nasal cavity, hard palate, zygomatic bone.

05/15/95 of otolaryngologist: oropharynx - the tumor is completely regressed, nasopharynx - the remainder of the tumor on the arch is determined.

Ultrasound of the abdominal cavity of 05/12/95: without pathology.

05/15/95. Optometrist: OD - axial exophthalmos, reposition is impossible. Eye mobility in full. The fundus without pathology. Clinically there is a tumor spreading to the right orbit, possibly from the main sinus

05/29/95 R-gram of the sinuses. Reduced transparency of n / 2 nasal cavities, right in upper maxillary sinus. The lateral wall of the right nasal cavity is destroyed, the fuzzy lower wall of the right orbit, the lower wall of the right upper jaw is destroyed, the projection of this sinus shows a highly intense shadow of 1-1.5 cm. The outer contour of the right zygomatic bone is not clear. Conclusion: a nasopharyngeal tumor with spreading into the nasal cavity, right maxillary sinus, right zygomatic bone, right orbit.

06.95. Osteoscintiography with TC. The foci of pathologically increased accumulation of the isotope merging with each other, respectively, to the bones of the base of the skull, jaw and zygomatic process on the right.

He browsed through the newspaper and found a rather big article. The article wrote about G. Grabovoi. First, it seems to be nothing special! Remarkable psychic data and clairvoyance. It turns out that this young man, from his childhood, had guessed and understood everything: he knew in advance whether there was cheese in the store, or, as a student, he foresaw the Chernobyl disaster. The vision came in the library, while preparing for the exams and made a terrible impression on him. Of course, he did not tell anyone about this - who would listen to the provincial student? said G. Grabovoi. And then an enumeration of amazing, hardly imaginable cases followed when G. Grabovoi turned people incurable from cancer into absolutely healthy ones. The method of treatment of G. Grabovoi was also surprising - he absolutely did not need to meet with the patients, he did not heal with the usual movements of his hands, etc.

T. Mushkudiani did not think long. He contacted the newspaper and established the address of G. Grabovoi, then contacted his office and took Georgiy directly from the hospital to Moscow. He was warned that it was not necessary to bring the patient, but was it really easy for a Georgian to believe in such a thing? Having met G. Grabovoi, he discovered that he was a clairvoyant and healer of a rather young age (G. Grabovoi was 32 years old).

According to Timur, the boy got better. Now Georgiy is completely healthy and is going to school. Timur says that he didn't buy any school supplies for Georgiy, since two months ago there could be no talk not only about the school, but about the fact that Georgiy would walk. According to Georgiy, he has a constant connection with his healer, he often hears the voice of G. Grabovoi. It turns out that G. Grabovoi and his patient became great friends. As the "Delovoy Mir" emphasizes, the saint blessed his work and called for promoting the unity of his country (he did not define the borders of his country).
