I declare that Grabovoi Grigori Petrovich really healed me of the disease of stage IV AIDS with scattered changes in various colors on the skin and increased size of the glands during 2 months.

The proof of this is that before the start of the extramural recovery carried out by G.P. Grabovoi, I had a confirmed diagnosis of AIDS by the dispensary of the Republican AIDS and Clinical Immunology Center of the Georgian Ministry of Health in Tbilisi for over three years. I had black, green, yellow spots on the body and also enlarged glands. After Grigori Petrovich conducted an extramural rehabilitation course, there is a record in the medical history extract dated December 21, 1995 from the Republican AIDS Center and Clinical Immunology of the Ministry of Health of Georgia that I was practically healthy. Indeed, there were no changes on the skin, the analysis of immunity was normal.

I was asked about a blood test in connection with the establishment of HIV infection in my spouse R.R., who was registered with the AIDS Center in Tbilisi since May 1992. He died in May 1995. Final diagnosis: HIV infection, stage IV AIDS, toxoplasmosis brain abscess, neurotoxicosis, neurovascular form.

Examination of my blood serum for the presence of antibodies to HIV was repeatedly carried out by

ELISA and NIF. All results were positive. Western Blot detected the presence of antibodies to HIV proteins.

Based on these laboratory data, at the Republican AIDS and Clinical Immunology Center of the Ministry of Health of Georgia in July 1992 I was diagnosed with stage IV HIV infection, generalized persistent lymphadenopathy (according to the classification of ATP). I did not take any drug treatment. All examinations before November 9, 1995 (including in Moscow) showed the presence of AIDS.

course from Grabovoi Grigori Petrovich, I, in addition to the tests confirming the presence of AIDS, had spots of various diameters and sizes, located in different parts of the body. The glands were also enlarged, on the basis of which the diagnosis of stage IV AIDS was made.

November 9, 1995, at the Georgian representation of Grabovoi Grigori Petrovich, I concluded an agreement that Grabovoi G.P. would carry out, in absentia, restoration of my health. At the same time, I recorded the presence of AIDS as the main diagnosis. Under the terms of the contract, I had to record the state of my health. Within a month from the start of the extramural treatment conducted by Grabovoi Grigori Petrovich since November 1995, the spots of black, yellow and green colors which I had on my legs disappeared and since the end of December 1995 I had no spots on my body. The skin was clean.

During the non-contact treatment conducted by Grabovoi Grigori Petrovich, I felt a pulsation in the glands, which in January 1996 decreased at a high speed. I felt well, I felt healthy.

On 12/05/1995 I had laboratory and instrumental examination in the dispensary of the Republican Center for AIDS and Clinical Immunology of the Ministry of Health of Georgia in Tbilisi with the attending physician L. Sharvadze. The examination according to the full program was carried out before 12/21/1995. Unlike all previous examinations, which were carried out for 3-4 days and the presence of AIDS was detected in all test systems, after taking restorative treatment in absentia from Grabovoi G.P., blood

The immune system, the general blood count is normal. It was written in the extract that I was in fact healthy and made recommendations: to conduct additional studies to confirm the diagnosis.

Taking into account that my skin was clean, the immunological examinations, the general analysis showed the norm, as well as the fact that antibodies of the HBsAg spectrum and others of a wide spectrum were not found that previously showed the presence of AIDS, I believe that Grabovoi Grigori Petrovich healed me of AIDS in 2 months.

EXTRACT

from the medical history

Patient M.G., 25 years old, widow living in Georgia.

M.G. was asked about a blood test in connection with the establishment of HIV infection of her husband L.R., who was registered with the Center with this diagnosis in May 1992. Died in May 1995. Final diagnosis: HIV infection, stage IV AIDS, C1 toxoplasmosis head abscess brain, neurotoxicosis - neurovascular form.

Examination of blood serum of M.G. for the presence of antibodies to HIV was repeatedly carried out by ELISA and NIF. All test results were positive, Western Blot detected the presence of antibodies to HIV proteins.

Based on these laboratory data, a diagnosis of HIV infection was established, and the patient was registered at the dispensary.

When being registered, the patient complained of an increase in lymph nodes in the cervical and axillary areas, which had bothered her for the past 6 months, and vaginal discharge and itching in the perianal region.

An objective examination of the patient revealed enlarged lymph nodes: the posterior cervical on the left - up to a diameter of 2 cm, axillary - on both sides, 3-4 knots to a diameter of 1.5-2.5 cm, inguinal - single on both sides to a diameter of 1.5 - 2 cm; painless, moderately dense consistency.

One of the latest issues of the "Obschaya Gazeta" (General Newspaper) (April 4-10, No. 13), published Vladimir Sudakov's article "From the Golden Throne in the Corner of the Universe" was published, telling about the amazing gift of Grigori Grabovoi, who heals hopelessly sick people. At the request of our readers, who were unable to find a rare issue, we reprint the sensational material with some reductions.

The husband died, leaving the widow rejected by all to wander in grief through the doctors' offices. She was diagnosed with AIDS, stage IV at the Republican Center for AIDS and Clinical Immunology. The patient was given medications, which she later admitted to throwing away, believing that they would not help. So she reached almost the last stage: Kaposi's sarcoma appeared. Everything was indicative of an imminent tragic denouement. However, the disease suddenly retreated. The lymph nodes began to decrease, the spots on the body were fading until they disappeared altogether. And here is the new conclusion of the doctors: "At present, the patient has no subjective complaints and feels healthy in fact. An objective examination did not reveal any changes in the lymph nodes ... The attending physician L. Sharvadze" The latest blood test for the virus was "clean"(!)
