Before the session, at the Oncological Scientific Center of the Russian Academy of Medical Sciences, my son was diagnosed with lymphosarcoma, blast type, pre-pre-B immunovariant with damage to the lymph nodes of the mediastinum of the lung, pleura, and bone marrow. The diagnosis was established on the basis of laboratory and instrumental examinations and puncture of bone and spinal cord, ultrasound of the mediastinum and chest.

After the session conducted by Grabovoi G.P. 11/11/1997, the puncture of the bone marrow and spinal cord of the son was taken on 11/11/1997, the conclusion was: the absence of tumor cells. After this, an ultrasound of the mediastinum and chest was performed, laboratory and instrumental examinations showed the normal state of health of the child.

All examinations (before and after the session) were carried out by the same specialists on the same equipment.
