The spleen is slightly increased in size, and there are three large of increased echogenicity, rounded metastases and similar single small ones are determined in the parenchyma.

The position and size of both kidneys are normal. No calculi were detected, the mobility of the kidneys was satisfactory, the pyelocaliceal systems were not expanded. On the right side in the adrenal gland, a distinct, increased echogenicity, oval 3.0×2.0 cm in size formation, probably metastasis of the adrenal gland.

CONCLUSION: metastasis of spleen, metastasis of adrenal gland on the right.
